ORDINANCE 2022-02
AN ORDINANCE AMENDING CHAPTER 6 OF THE AVOCA CITY CODE
PERTAINING TO THE BOARD MEMBERS

BE IT ENACTED by the City Council of the City of Avoca, Pottawattamie County, Iowa:

SECTION 1. Amended. Chapter 6.6 will be amended as follows:

6.6 **Golf Course.** The purpose of this section is to establish a Municipal Golf Course and Clubhouse service for the City.

- A. **Board.** There shall be established an Advisory Board for the Avoca Municipal Golf Course and Clubhouse consisting of 5 people: 4 citizens of Avoca who have attained the age of 18 and 1 person who can live outside city limits who has a membership with Avoca Municipal Golf Course. Each term shall commence on the first day of April.
1. **Appointment.** The Council shall appoint the members of the Board to terms of four (4) years. One-third of the appointments to the Board shall be made every year or as near as possible, to stagger the terms. The initial appointments to the board shall specify two two-year terms and four (4) year terms; thereafter all appointments, other than interim replacement appointments, shall be for a four-year term.
 2. **Compensation.** All members of the Board shall serve without compensation, except their actual expenses, which shall be subject to the approval of the Council.
 3. **Duties and Responsibilities.** The Board shall have the following duties and responsibilities;
 - a. **Personnel.** The Board will not have the authority to hire or terminate employees; authority to hire and terminate employees will remain with the Administrator.
 - b. **Rules and Regulations.** Subject to the subsequent approval by the Council, the Board may recommend rules and regulations for the use of golf course facilities. Such rules shall be posted on the facility or otherwise publicized in a manner to provide adequate notice to the public.
 - c. **Fees.** Subject to the subsequent approval by the Council, the Board may recommend the establishment or imposition of all appropriate charges and fees for the use of the golf course, golf clubhouse, and any other facilities located on the golf course premises.
 - d. **Operations and Marketing.** The Board shall recommend an operational and marketing plan for the golf course facility.
 - e. **Subject to Policies.** The Board will be subject to the financial policies, purchasing policies, and employee policies as adopted by the Council.
- B. **Administrator.** The Administrator shall serve as the administrator for the Board. All policies of the Board shall be coordinated through the Administrator.

SECTION 3. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 4. Severability. If any section, provision or part of this ordinance shall be adjudged to be unconstitutional or invalid, such adjudication shall not affect the validity of this ordinance as a whole, or any section, provision or part thereof not adjudged unconstitutional or invalid.

SECTION 5. Effective Date. This ordinance shall be effective from and after its final passage, approval and publication as provided by law.
